EXECUTIVE COMMITTEE MEETING MINUTES

**NOVEMBER 3, 2010**

Big Sir Larry Shelley called the meeting to order at 10:45 am.

**SECRETARY REPORT**

**TREASURER REPORT**

Treasurer Bill Martin reported a beginning balance of \$1,553.17, income in October of \$781.68, expenses of \$956.62, with a closing balance of \$1,378.23. This represents a loss of \$174.94 for the month, and a total loss of \$38.37 year to date.

Outgoing Big Sir Larry Shelley made a point of personally thanking all the officers & committee chairmen on the BEC for their contributions to SIR Branch 170 throughout 2010. He paid special recognition to Bill Martin, who has served as the Branch Treasurer the last eight years.

Mel Pimentel announced that this month's speaker is Don Cochran from CalFire. Mr. Cochran is the Air Tech Supervisor who oversees all aircraft deployed to put out wildfires in our general area.

## MEMBERSHIP REPORT

Phil Jones mentioned that we had recently lost two members - I passed away, and 1 moved. However he plans to induct five new members today. He also mentioned our turnout for lunch today was nearly 80 members.
