

Knee Deep leased the former Beermann's Brewery in Lincoln before moving to their new 28,000 square foot facility in Auburn, CA. They have 14 year round beers on tap. Knee Deep received several awards; most notably the Hoptologist DIPA (my favorite) which took the Gold Medal in 2013 at The Bistro 14th Annual DIPA Festival. Knee Deep has a rapidly growing reputation and is becoming known for their unique blends and creative outlook on brewing. I'm sure you will be able to find something to quench your thirst plus something to compliment your beer from JJ's Smoke-N-BBQ food truck that will be at the Brewery from 3:30-8:30 PM
